

Technology-enabled VAT number improvement

A valid VAT registration number of customers is required for applying the 0% VAT rate on cross border supplies within the EU. Not having a valid number may result in VAT assessments and penalties. It can be very burdensome to manually validate all your customer's numbers.



We helped a global cosmetics company to reduce costs and compliance risks by implementing an end-to-end managed service that periodically


- 1. extracts VAT numbers from SAP without manual effort
- 2. performs 50k+ checks automatically against EU VAT Information Exchange System (VIES)
- 3. presents the results on an user-friendly website

Given the significant number daily intracommunity supplies, checking the VAT number per transaction was not feasible as the EU VIES system accepts a limited number of requests per day. If the check would have failed as a result, it would have delayed business operations. In addition, our client explicitly wanted to make use of our managed service model to minimize the efforts required from the IT department.
